22/05/03 Public Participation: Ray Brown notified the PC that the Chairman of the Village Hall Committee was in hospital and the Treasurer had resigned.

22/05/04 Questions for - and Update from - Buckinghamshire Councillor - Derek Town

The Buckinghamshire Monthly Councillors report had been circulated and was on the website. The White Lion was reported to be subject to a habitat survey. No update on the Enforcement of businesses operating without permission on Marsworth Airfield.

#### 22/05/09 Streets, Footpaths and Recreation Ground

- a) Recreation Ground: GM had inspected the Rec and found no issue. A request had been made to secure the goal post netting to the ground as only secured at one end of pitch.
- b) Pruning of Trees at the Millennium Hall. A request had been received to consider pruning of trees at the village hall to protect parked cars. This usually took place every 5-6 years and had last taken place 2 years ago. It was resolved to reconsider this request during the Winter period.
- c) Query in relation to **Encroachment of Village Green** with tables and chairs at the Red Lion. It was resolved that the tables and chairs should be considered available for the use of everyone within the village.
- d) It was resolved that the MVAS Shared with Cheddington PC would no longer be required as a SID (speed indicator device) would be in situ shortly.
- e) Grass Running Track along inside perimeter of Marsworth Rec. A quote had been received for a painted white line running track. It was resolved to obtain a quote from John Groom to mow a running track (with shorter grass) but without white lines as it was felt the grass would remain short if it was well used. An article to be put in Marsworth News asking residents to contact the Clerk if they were supportive or not.
- f) Gravel Path Marsworth to railway bridge at Pitstone. It was resolved to proceed with the quote in the sum of £500 from J Leonard to clear weeds etc from the gravel path.
- g) Bin stickers It was resolved that the Clerk should order 200 x 30mph bin stickers and that an article would be put in Marsworth News for residents to contact the Parish Clerk if they wanted any.
- h) Parish Notice Board by the Red Lion. It was resolved to discontinue the use of the notice board at the Red Lion as it needed replacing. It was resolved that DC would contact the Church Warden to ask if the Church would consider sharing their noticeboard with the Parish Council for Agendas.
