Questions for - and Update from - Buckinghamshire Councillors

The Buckinghamshire Monthly Councillors report had been circulated and was on the website. No update on the Enforcement of businesses operating without permission on Marsworth Airfield. - e) Gutters and pavements in Lower End. TfB to organise for vegetation to be cut back along pathways (Nov 21). Pavement now collapsed. Clerk to report this also.
- f) Clerk awaiting update from VAHT on when garages at The Crescent are due to be demolished and rebuilt.

It was RESOLVED that Councillors should email the Clerk by 1 July with their objections to the development for the Clerk to collate and submit to Dacorum Council.
