### **1.** What are the LNRS introductory webinars?

#### What is the Local Nature Recovery Strategy (LNRS)?

Local Nature Recovery Strategies (LNRS) were introduced in the Environment Act 2021. These are plans that will help drive more coordinated, practical, focussed action and investment to



help nature and people flourish together, whilst delivering wider nature-based environmental benefits. They will consist of:

- A Statement of Biodiversity Priorities, which reflect stakeholder priorities for environmental outcomes, and the actions that need to be undertaken to achieve these outcomes.
- A Local Habitat Map, which will identify the location of areas already important for biodiversity, overlaid by locations considered suitable for delivering the priority outcomes and actions identified by stakeholders.

This new system of spatial strategies will: support efforts to recover nature across England; help planning authorities incorporate nature recovery objectives; support the delivery of Biodiversity Net Gain; and help deliver our national environment targets.

#### Who is in charge of managing the Buckinghamshire and Milton Keynes LNRS?

Defra will designate 'Responsible Authorities' or RAs for each of the LNRSs. In the case of Buckinghamshire and Milton Keynes, the RA will be Buckinghamshire Council. In addition, the LNRS Regulations identify 'Supporting Authorities' or SAs, who will act as supporting partners in the LNRS development process. In this case, the SAs will be Milton Keynes City Council and Natural England. The ultimate decision-making lies with the RA, with the agreement of the SAs. For the Buckinghamshire and Milton Keynes Natural Environment Partnership (NEP) to serve as the project manager. Additionally, the LNRS process is meant to be collaborative, and will involve a high level of stakeholder input.

#### Will attendees have the opportunity to ask questions?

Yes. Attendees will have the opportunity to ask any questions in the webinar chat, and there will be a dedicated Q&A section towards the end of the webinar to answer the questions that may come up.

#### What will happen to the information attendees provide during the webinar?

There may be some interactive polls / information capture activities conducted during the event. The information gathered via these exercises will not identify any individual or group, unless they wish to identify themselves. The information will not be directly publicly shared, rather be used in a consolidated manner to inform the process and priorities of the LNRS, as appropriate. Attendees will be made aware of how any information they provide will be used prior to the commencement of the activity during the webinar, and participating will always remain optional. Pertinent questions attendees ask during the webinar will be complied (without any personal identifying information) into an FAQs document that will be published on the NEP's and Buckinghamshire Council's websites.

## Does registering for the webinar mean the registrant will automatically be signed up for the LNRS mailing list?

No. Registering for the webinar will simply mean the attendees will receive via email the joining link and a recording of the webinar in a single follow-up email. In the follow-up email,



there will be a link to sign up for an LNRS mailing list. Only if attendees sign up through this additional link will they receive additional correspondence about the LNRS.

# If someone is unable to attend the webinar but still wants more information, what should they do?

If someone is unable to attend the live webinar, they may access the webinar recording on the NEP's website (<u>www.bucksmknep/LNRS</u>) a week after the webinar date. We also strongly encourage anyone interested in receiving a copy of the webinar to register, even if they are unable to attend, as they will receive a recording of the webinar directly to their email.

#### Can anyone share information about the webinar?

Yes, we encourage anyone who thinks they may know someone who might benefit from learning about the LNRS to share the posters or re-share any information they receive regarding the LNRS intro webinars. We request, however, that information is not edited to provide any false information about the LNRS or its introductory webinars.

#### What is the NEP?

NEP is short for the Buckinghamshire and Milton Keynes Natural Environment Partnership. The NEP brings together a diverse range of individuals, businesses and organisations to drive positive change in the local natural environment. The NEP promotes the value of the natural environment in decision making at all levels and takes a strategic view of the challenges and opportunities facing nature. The NEP is working alongside the Local Enterprise Partnerships (LEPs) and the health and wellbeing boards to embed natural environment in growth, economic & health strategies, and develop interventions and programmes for delivery. All the webinars will be facilitated by the Buckinghamshire and Milton Keynes LNRS's Project Manager and Natural England LNRS Senior Advisor. Some sections of the webinars may also include other experts on certain topics, such as Biodiversity Net Gain.

#### Who should attend the webinars and why?

Anyone interested in learning about the LNRS is welcome to attend the webinars. We do recommend that you choose the webinar that you think is most pertinent to you. The webinar groupings include farmers / landowner / foresters, businesses, developers, Town & Parish Councils, NGOs and community-based organisations, and interested residents. The LNRS is an exciting opportunity with a high level of stakeholder consultation, which means we want to hear from stakeholders about what they think are priorities for nature, how we can align the LNRS with existing work being undertaken to improve and recover nature, and how the LNRS can provide you with opportunities and benefits.
